3. Accept positions of responsibility in the work of the Foundation. Trustees will chair the different committees set up to attract charitable giving.
4. Contribute meaningfully to the Foundation's deliberations and work.
5. Use personal or professional knowledge to support Foundation programs and to advise the Chair on such matters for which specialized knowledge is pertinent and may be helpful.
6. Serve actively as ambassadors of good will for the Foundation and promote the Foundation to groups and individuals.
7. Help seek volunteer leadership to carry out the Foundation's work.
8. Help evaluate and coordinate Foundation projects and programs.
9. Act as a "community sounding board" for problems that could affect the Foundation.
10. Model exemplary giving in time, energy and resources.
11. Actively solicit financial support for the Foundation.
